ADB Releases the First Tranche of the SASEC Chittagong-Cox's Bazaar Railway Project

21 June 2017: Dhaka, Bangladesh

The Asian Development Bank (ADB) and the Government of Bangladesh have signed a \$300 million loan agreement, the first tranche of the \$1.5 billion SASEC Chittagong-Cox's Bazaar Railway Project. Set for completion in 2022, it will be linked to the Trans-Asian Railway route, provide for future direct connectivity toward India, Bhutan, and Nepal through the Indian Railway network, and help boost Cox's Bazaar as a major tourist destination.

ADB to Increase Support for India's East Coast Economic Corridor

29 June 2017: New Delhi, India

Asian Development Bank (ADB) President Takehiko Nakao told India's leaders that ADB is increasing support for developing economic corridors under the Make-in-India initiative, following ADB's new country strategy for India for 2018-2022. ADB is prepared to invest up to \$5 billion during 2018-2022 to develop the East Coast Economic Corridor.

23 June 2017: Phuentsholing, Bhutan

A groundbreaking ceremony initiated construction of the mini dry port in Phuentsholing, Bhutan. The project, costing around \$2 million, is funded by an Asian Development Bank grant, with additional funding from the Government of Bhutan. This dry port will improve Bhutan's logistics capability and augment its trade competitiveness.

13 June 2017: Manila, Philippines

The interim report for the Southwest Bangladesh Economic Corridor envisages huge economic gains for Bangladesh, including enhancement in Bangladesh's human capital, technological level, infrastructure, and backward linkages, and total output of the southwest region to \$148 billion by 2050 – more than 3 times higher under the business-as-usual scenario.

SASEC Economic Corridors to Improve Connectivity between India and Neighbors

5 June 2017: Kolkata, India

Two economic corridors being developed under the South Asia Subregional Economic Cooperation (SASEC) are now in the pre-construction stage. The economic corridors would improve international trade and connectivity among Bangladesh, Bhutan, India, and Nepal.

She noted the need to fast-track completion of the inland waterway linking Sittwe Port to the Myanmar hinterland, and move forward with the Motor Vehicle Agreement negotiation to facilitate seamless movement of cargo.

27 June 2017: Kathmandu, Nepal

A forum in Kathmandu, Nepal explored actions that will allow landlocked countries to take advantage of being "land-linked". Mr. Bipul Chatterjee, Executive Director, CUTS International, underscored the importance of cooperation among the four countries to be able to move forward.

The Bangladesh Executive Committee of the National Economic Council approved a road widening project for the 51-kilometer road from Ashuganj River Port to Akhaura Land Port used by Bangladeshi exporters for transshipment of goods. The upgrade is a move to ease traffic and improve road safety.

BBIN Intraregional Trade On the Rise

21 June 2017: Geneva, Switzerland

The International Trade Centre's Trade Map reports an increase in intraregional trade in the Bangladesh-Bhutan-India-Nepal (BBIN) subregion in 2016, from \$21.65 billion in 2015 to \$23.52 billion. The ratio of BBIN intraregional trade to world trade went up from 2.98% in 2015 to 3.34% in 2016.

19 June 2017: New Delhi, India

The Government of India ratified the United Nations Transports Internationaux Routiers (TIR) Convention, becoming the 71st country to accede to this worldwide Customs transit system, which has the widest geographical coverage. Accession promises to be a boon to India's trade, and contribute to an integrsted economy with global and regional production networks.

Bangladesh, Sri Lanka to Hold Trade Talks in July

15 June 2017: Colombo, Sri Lanka

Bangladesh and Sri Lanka will hold high level talks in July 2017 in Dhaka, Bangladesh, to deepen trade and expand investment. Mr. Rishad Bathiudeen, Sri Lanka Minister of Industries and Commerce, noted that while Sri Lankan exports to Bangladesh have tripled since 2010, Sri Lanka wants to explore many untapped bilateral opportunities to further boost trade growth.

The India-Bangldesh Border Haat Management Committee met to finalize the lineup of vendors for a border haat set to rise in Tripura, India. The committee has selected Kamalpur, Dhalai, as the site for the new border haat.

The message was issued to mark BIMSTEC's 20th anniversary.

Sri Lanka Makes Big Push for Renewable Energy

21 May 2017: Colombo, Sri Lanka

Of Sri Lanka's 4,000 megawatts (MW) installed electrical capacity, the country generates 550 MW from wind and solar energy sources. By pushing to increase its renewable energy capacity and exploring the possibility of building undersea power cables, Sri Lanka could open the doors to mutually beneficial energy trade with India.










Business Process Analysis of Import of Light Motor Vehicles from Third Countries to Bhutan via Kolkata Port




Business Process Analysis of Import of Kitchen and Table Wares of Plastics from Bangladesh to Bhutan




Business Process Analysis of Export of Ferro Silicon from Bhutan to the Third Countries
